## **Booking conditions:**

- The booking fee is 8€ non-refundable
- The deposit must be sent to us 7 days after receipt of the booking option
- The dates of your stay may be changed up to 15 days before the date of the stay depending on availability, after this period no date changes can be made and the entire stay will be due upon your arrival (on the reserved dates)
- The reservation must be made at least 3 days before the arrival date.
- Any extension of stay or early arrival can only be made depending on the places available, nor the same pitch/mobile home/pod as the one reserved. We will do our best to satisfy you.
- The campsite reserves the right to change your pitch if necessary.
- The reservation is kept until 6:00 p.m. on the day of the scheduled arrival. Beyond this time, and without news from you, your pitch/mobile home/pod will no longer be reserved and your reservation will be considered cancelled.
- A mobile home or pod reservation is made from the day of arrival 4:00 p.m. to the day of departure before 11:00 a.m.
- A pitch reservation is made from the day of arrival 12:00 p.m. to the day of departure before 11:00 a.m.
- Any departure after 12:00 p.m. will result in the payment of an additional night.
- The deposit of 30% of the total amount of your stay will be collected upon reservation. Payment will be made either by check or credit card (in this case, notify us and we will send you an email with a secure payment order). Holiday vouchers are not accepted for payment of deposits.
- Payment for the stay should be made on the day of arrival
- Any stay that is cancelled, shortened or interrupted will not give rise to any refund for any reason
- A deposit of €250 for pods and €500 for mobile homes will be requested upon arrival, it will only be taken in the event of damage.
- For any cancelled booking, the deposit will be lost regardless of the reason. Not refunded, except in the event of subscription to cancellation insurance (see conditions below).
